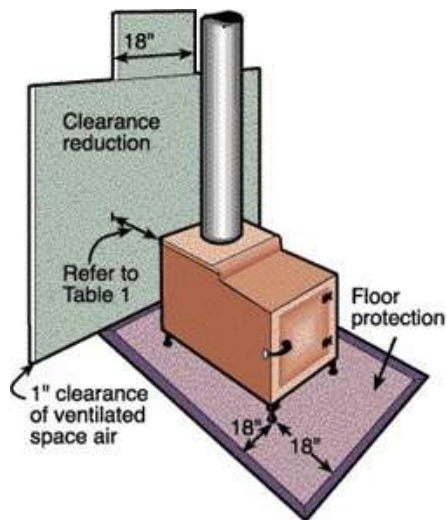
## Guidelines & Tables

### ❑ **Walls & Ceilings**

Table 1 shows NFPA-recommended clearance between wood stoves and protected and unprotected combustible walls and ceilings. Figure 1 illustrates these clearances and shows how protection is installed.
